

WAGGA FUTSAL DISCIPLINARY PROCEDURES 2025-2026

Pre-amble

The below procedure aims to detail Wagga Futsal's process in dealing with disciplinary or grievance matters.

The procedure is based on the Football New South Wales Grievance and Disciplinary Regulations. In the event of any inconsistency between these Regulations and this procedure, the Regulations will prevail. Grievance Policy Tribunal shall be deemed as GPT.

<u>SECTION 1 – PLAYERS</u> Yellow card codes

Y1: Unsporting behaviour: A broad category that can include things like a reckless tackle, simulation, or a tactical foul to stop a promising passage of play.

Y2: Dissent by word or action: For showing disagreement with a referee's decision through words or gestures.

Y3: Persistent infringement: Repeatedly committing fouls or breaking the rules after being warned.

Y4: Delaying the restart of play: Intentionally holding up a restart, such as a free kick or kick-in.

Y5: Failure to respect distance: Not moving the correct distance away from the ball for a restart like a free kick, corner kick, or kick-in.

Y6: Entering or re-entering the field without permission: Going onto the field without the referee's authorization.

Y7: Deliberately leaving the field without permission: Leaving the field of play without the referee's consent.

Infringement of the substitution procedures.

Send Off Codes For Wagga Futsal - Players

R1. Serious foul play when challenging for the ball. (Mandatory 1 match suspension plus option of 2nd match if deemed necessary by the nature of the incident)

R2. Assault on a Player - violent conduct when not challenging for the ball.

(Mandatory 1 match plus option of 2nd match if deemed necessary by the nature of the assault)

R3. Spitting at a player.

(Mandatory 1 Match plus 5 additional matches)

R4 or R5. Denying the opponent an obvious goal scoring opportunity.

(Mandatory 1 Match plus option of 2nd Match if deemed necessary for repeat offenders)

R6. Serious Unsportsmanlike Conduct.

(Mandatory 1 Match Suspension PLUS 1 Extra Match)

R6. Use of discriminatory language and/or gestures, including racist, religious, ethnic or sexist.

(Mandatory 1 Match Suspension PLUS 4 Additional Matches)

R7. Second caution in the same match.

(Mandatory 1 Match Suspension, Maximum 2 Matches)

R2 or R6. Inciting a brawl on or off the pitch.

(Mandatory 1 Match Suspension plus option of up to 4 Additional Matches)

SECTION 2 – COACHES/MANAGERS/SUBSTITUTES

Offences in technical area for Wagga Futsal – applicable to coach/manager/substitutes

Yellow card codes

- Y1: Unsporting behaviour.
- Y2: Dissent by word or action: For showing disagreement with a referee's decision through words or gestures.
- Y3: Persistent infringement: Repeatedly breaking the rules after being warned.
- Y4: Delaying the restart of play: Intentionally holding up a restart, such as a free kick or kick-in.
- Y5: Failure to respect distance: Not moving the correct distance away from the ball for a restart like a free kick, corner kick, or kick-in.
- Y6: Entering or re-entering the field without permission: Going onto the field without the referee's authorization.
- Y7: Deliberately leaving the field without permission: Leaving the field of play without the referee's consent. Infringement of the substitution procedures.

<u>Send Off Codes For Wagga Futsal – coaches and officials</u>

R1. Serious Foul Play: Mandatory 1 match. Maximum 24 Months.

R2. Assault of a match official: Mandatory 1 match PLUS 6 Month Ban From All Futsal activities.

Maximum 24 Months Suspension

R3. Spitting at a Opponent, Match Official or any other person:

Mandatory 1 match PLUS 6 Month Ban From All Futsal activities.

Maximum 24 Months Suspension

R4. Denying a goal scoring opportunity: Mandatory 1 match. Maximum 2 matches.

R5. Denying a goal scoring opportunity: Mandatory 1 match. Maximum 2 matches.

R6. Offensive, insulting or intimidating language and/or gestures: Mandatory 1 match. Maximum 24 months.

R7. Second Caution: Mandatory 1 match. Maximum 2 matches.

SECTION 3 – SPECTATORS

Offences by supporters or spectators.

SPECTATORS AND SUPPORTERS

- (a) These Regulations, the Football NSW Terms of Admission Policy and the FA Spectator Code of Behaviour apply to all Spectators attending any Match or any training session conducted by or on behalf of a Club.
- (b) Football NSW and Tribunals have jurisdiction to determine matters involving Spectators and to issue sanctions against:
- i. Spectators;
- ii. Players or Officials who are children or wards of any Spectator, in respect of the behavior of that Spectator; and
- iii. Clubs, in respect of the behaviour of any Spectator/Supporter.

- (c) In the event of an alleged breach of these Regulations, the Football NSW Terms of Admission Policy and/or the FA Spectator Code of Behaviour, Football NSW may refer the matter to the General Purposes Tribunal pursuant to section 9.2 (Charges of Misconduct) and seek an appropriate sanction including, but not limited to, banning a Spectator from attending Matches or suspending a Player or Official (who is the child or ward of a Spectator) from participating in Matches.
- (d) Any ban imposed by FA under the FA Rules and Regulations against a person may be endorsed and applied by Football NSW across all Matches and across all matches and competitions sanctioned or administered by Clubs, Centres, Summer Football Competition Administrators, Association Members, Branches, Regional Associations and their clubs.
- (e) Any ban imposed by a Member Federation, Club, Centre, Association Member, Summer Football Administrator, affiliated association or their clubs under their applicable rules and regulations may be endorsed and applied by Football NSW across all Matches and across all matches and competitions sanctioned or administered by Clubs, Centres, Summer Football Competition Administrators, Association Members, Branches, Regional Associations and their clubs.
- (f) A Club is responsible, and liable, for the conduct and behaviour of its Supporters, whether at home or away Matches. A Club is deemed to have breached these Regulations where its Supporters engage in Misconduct at or in connection with a Match, Competition or event or activity staged or sanctioned by Football NSW.
- (g) It is the Home Team's responsibility to ensure the Football NSW Terms of Admission Policy and the FA Spectator Code of Behaviour is implemented and enforced against all Spectators.
- (h) The Home Team is liable for improper conduct among its own group of Supporters. Supporters occupying the home sector of a stadium, ground or centre are regarded as the Home Club's Supporters, unless proven to the contrary (as determined by Football NSW in its sole and absolute discretion).
- (i) An Away Club is liable for improper conduct among its own group of Supporters. Supporters occupying the away sector of a stadium, ground or centre are regarded as the Away Club's Supporters, unless proven to the contrary (as determined by Football NSW in its sole and absolute discretion).
- (j) A Club is responsible for ensuring that sanctions imposed on its Spectators/Supporters are enforced and adhered to. Any Club which fails to do so will be deemed to have committed Misconduct (section 16.4) and the Executive may, in its absolute discretion, take any relevant action against the Club pursuant to section 9.2 (Charges of Misconduct).

	Wagga Futsal receives an allegation of an offense. This may come in several forms, including but not limited to:
	1. A Referee's or Assistant Referee's Report
	2. A written allegation from a Wagga Futsal Member Team
PHASE 1	 A written allegation from a Wagga Futsal Individual member (e.g. player, coach, spectator)
	Wagga Futsal may seek further written statements to support the allegation.
	Wagga Futsal will generally rely upon statements provided to it.
	Wagga Futsal may seek advice from FNSW or from members of its Judicial Panel.

Phase	DECISION: Wagga Futsal will determine whether the allegations could lead to a Charge being
	laid. If in its opinion it could, Wagga Futsal will move to Phase 2a or Phase 2b at its absolute discretion.
	If at this stage Wagga Futsal decides that no further action will be taken, the matter will be dismissed.
	Wagga Futsal may give the defendant the opportunity to provide written statements. Wagga Futsal will:
	1. Provide the defendant with a copy of the original statement containing the allegation.
PHASE 2a	Give the defendant a time period in which to provide a statement.
	If the defendant chooses not to supply a statement, this in no way would be considered an

PHASE 2b	Wagga Futsal may, at its sole discretion, proceed directly from Phase 1 to Phase 3 without
